Clearing Agents are reminded of and are asked to note the following Customs Regulations.

183. A person may not transact business with the Customs on behalf of others unless he holds a licence to do so by the Comptroller of Customs. The license shall be in the form C.43 and shall be valid from the date of issue until 31st December in the same year. The fee to be charged for such licence shall be \$750.00

184. A clearing agent's licence shall not be issued to any person who fails to satisfy the Comptroller that he has sufficient knowledge of Customs procedures to transact business with the Customs in an efficient manner, and any such licence may be cancelled by the Comptroller if the holder thereof is concerned in the commission of any offence against the Customs Laws or Regulations.

185. A person shall not be required to hold a licence to transact business with the Customs on his own behalf.
