
## APPOINTMENTS FOR CARGO COLLECTION Actioned by the Clearing Agent

## HOW TO MAKE AN APPOINTMENT FOR CARGO COLLECTION

- 1. To make an appointment, begin by visiting our appointment portal at <u>www.barbadosport.com</u>.
- 2. Select Track/Collect Your Cargo.



3. Enter the **Delivery Order Number** located on the top right corner of documentation to check the status of the cargo.
